

Complete this form to calculate your Manitoba community enterprise development tax credit. You can claim this credit if you received a Slip T2CEDTC (MAN.), *Manitoba Community Enterprise Development Tax Credit*.

The credits you earned in 2017 and in the first 60 days of 2018 are refundable. The unused credits from previous years can be used to reduce your Manitoba tax payable for that year. Any unused amounts can be carried forward for ten years.

If you are filing online, keep all your documents in case we ask to see them at a later date. **If you are filing a paper return, attach this form and your Slip T2CEDTC (MAN.).**
